Commissioner Paul Slowe: Please call Mr. Caesar. Well, this is Caesar you are here pursuant to the summons that you got.

Mitchell Caesar: Yes sir.

Commissioner Slowe: Are you a Christian?

Caesar: Yes sir.

Commissioner Slowe: So you haven't converted as yet

Caesar: No sir I am a Christian

Commissioner Slowe: Do you swear to tell the truth the whole truth and nothing but

the truth so help me God?

Caesar: I do so swear.

Commissioner Slowe: Right so just stay to your name for your record your name your rank where you stationed and so on.

Caesar: Right I am Mitchell Caesar. Detective Assistant Superintendent of Police and I am stationed at CID Headquarters Eve Leary. I am the Head of the Major Crime Investigation Unit.

Commissioner Slowe: Okay alright the matter tell me how this matter came to your attention and what happened and what you did and so on. Again, let me just say that you are being recorded so there is no need for you to pause and try to write and so on because it is recorded.

Caesar: Right, it was on the 29th of March sometime mid morning hours I was called to the Crime Chief's office Wendell Blanhum, Senior Superintendent of Police. As I arrived there I met a gentleman who I learned his name to be Andriff Gillard. In the company of Superintendent Michael Gibson. Mister Blanhum allowed Mr. Gillard to repeat his story and his story in which he would have alleged that he was paid he was offered seven million dollars by a guy by the name of one of the Khan brother's to assassinate the President David Granger. After the interview, Mr. Blanhum instructs that I conduct an investigation into the matter. I left the office within the company of Mr. Gillard and went to my office on the second floor. At that time I call Detective Sergeant Komal Pitama.

In my office I interviewed and ask Gillard again so as to get the story clearly after which I instructed Pitama to personally take a detailed statement from Gillard after which I instructed him that upon the completion of that to take a party to the home of Khan if he's there to conduct a thorough search of his premises for the alleged firearm. Mr. Gillard would have spoken about. Gillard's statement was lengthy it was some 15 pages so it took some time before Pitama got through with it and this was reported to me at which stage I instructed immediately go and search the Khan. At this time I would have contacted the Police Advisor Justice Claudette Singh. This is normal from time to time when we have a report from time to time I would contact her to find a way forward and ironically that day I wasn't feeling well so I left after indicating to the Crime Chief that I'm not feeling well and I left.

Nevertheless, I stayed in contact by telephone as to the every move about three-quarters and hour after 11 o'clock I called to check back what was going on and the Pitama told me that they were still in traffic and they were caught in the 4 o'clock traffic on the East Bank. So, later on, he called me and told me that they got there and they got in contact with Mr. Khan and they would have searched the premises and they found nothing in relation and they're on their way to CID headquarters by this time I got home I stayed in contact my instruction was that we should push as far as we could that night so they make proper documentation of his arrest and have him confronted with Gillard if possible again Khan should be placed in custody.

Sometime after 7:30 I received the call from Inspector Narine informing me that he received instructions to put Mr. Hhan on bail, cash bail. His exact words were Chief instruct me to put Khan on bail. At that stage, I told him to hold on let me speak to Mr. Blanhum and he said no it's not Mr. Blanhum it was the Commissioner of Police, Seelall Persaud. And I said okay well if the Police Commissioner so instructs then there isn't anything I can do at a time. I stayed in contact with Narine up to until nine and I fell asleep because of some medication I was using at the time I woke up the following morning I arrived at work at 7:15, as usual, I immediately started to look at the matter again by which time shortly after I saw Khan came and I interviewed him again.

Sometime in the said morning, I went to the police legal advisers office with the statements and the records that we had at that time I got the direction I went back and retained (inaudible) until the 5th of July. I left the country for a few days upon my return I ensure that the file was prepared and sent off for legal advice and shortly after about 2 or 3 days we got back the file and we were asked to do some additional stuff we completed that and sent the file again shortly after which in four days we were provided with legal advice that we should not pursue the investigation based on not enough evidence on file to charge anyone so then that was it.

Commissioner Slowe: Let me just seek to get some clarity on a few issues, you are called to Mr. Blanhum's office and there you met Winston and Gillard until you took them downstairs you interviewed Gillard and you took the story and then instructed Pitama...you also interview him?

Caesar: No sir.

Commissioner Slowe: You did the interview?

Caesar: Yes the purpose was him to....

Commissioner Slowe: Here what's going on...

Caesar: Yes and that's just to what really transpired.

Commissioner Slowe: The reason why I ask that is because Pitama he conducted the

interview?

Caesar: No.

Commissioner Slowe: He didn't conduct the interview?

Caesar: No, I interviewed him.

Commissioner Slowe: All of this was to take a statement?

Caesar: Probably when he went outside I don't know if he would have but I

interviewed him.

Commissioner Slowe: This is a lot of interviews cause I mean even before then Commander Hickens interviewed him the Crime Chief interviewed him and you took him down and you interviewed him I know there's a suggestion that the time I might have interviewed him again on the very same matter alright, now tell me something about before we going to the other thing you're the man you're the head of this unit for how long?

Caesar: About 3 years.

Commissioner Slowe: About three years and how long has this unit been in

existence?

Caesar: About 6 years?

Commissioner Slowe: And what the staff is like for the unit?

Caesar: We have seventeen ranks. There are two Inspectors, two Sergeants, four or five Corporals. Seventeen in all.

Commissioner Slowe: Alright don't worry. Is there any SOP within the functioning of this unit?

Caesar: Not written.

Commissioner Slowe: So there is no written SOP?

Caesar: No sir.

Commissioner Slowe: To the best of your knowledge, what is the determination, who decides matters that are to be investigated in this unit?

Caesar: Comes from the Crime Chief

Commissioner Slowe: Crime Chief determines that?

Caesar: Yes Sir

Commissioner Slowe: Do you know about what time Pitama and the guys left to go wherever you instructed them to go by Khan. By Khan the man who these allegations were made?

Caesar: Anytime after three.

Commissioner Slowe: And you're saying that you kept in contact about how many times?

Caesar: I spoke with him roughly between 2 or 3 the least would've been two times.

Commissioner Slowe: The least would have been two times, and during that time you gave them guide?

Caesar: Yes sir.

Commissioner Slowe: Did you advise that they should obtain a search warrant before they go to this place to search?

Caesar: No sir I did not, given the seriousness of the matter and I thought I wanted us to maintain the trusted weapon of the police force, the element of surprise. I decided to stem power to ensure that Khan was being located on the premises it was a thought before I thought that was the best at the time.

Commissioner Slowe: Let me get this clear so when they went there was not necessarily to arrest but to lock off the premises?

Caesar: And with the probability of searching to arrest if possible but I wanted to ensure Khan was in custody before anything was out of control

Commissioner Slowe: So what would have happened if they got there and things got out of control?

Caesar: I would've made arrangements for them to have a search warrant, sir.

Commissioner Slowe: You are in the presence of Mr. Blanhum when Gillard repeated the story, you went downstairs, again the same story was repeated by then did you form an opinion the source would be necessary?

Caesar: Yes.

Commissioner Slowe: So why you didn't look to get a search warrant then?

Caesar: As I said, sir, I...

Commissioner Slowe: Corporal let me just intervene because you are stating that this statement took a long time, this statement taken by Pitama. You said 16 pages Crime Chief said 17 I ain't gone call a lie upon one page but that took from all indications a long time enough time to retrieve a search warrant.

Caesar: Time was not the essence I was trying to keep the information to least persons as possible.

Commissioner Slowe: Yes but if you had tried to get the search warrant maybe it might have helped.

Caesar: Yes sir.

Commissioner Slowe: They told you to search and nothing was found and they went back to CID with the person. So Khan was arrested?

Caesar: Yes sir.

Commissioner Slowe: They had him in custody?

Caesar: Yes sir.

Commissioner Slowe: And they went back to CID Headquarters with him?

Caesar: Yes.

Commissioner Slowe: Now tell us first thing you indicated that you went to the police legal advisor even before they went down to Diamond?

Caesar: Yes sir.

Commissioner Slowe: For what purpose?

Caesar: Normally in every investigation some of the pending investigation assigned to the MCIU, I would make contact with the police legal advisor tell her what we have and what is our mentions. She would have her input from then on to the end of the investigation.

Commissioner Slowe: So she didn't advise you to take a search warrant?

Caesar: No.

Commissioner Slowe: Let me see if I get this straight so they returned to CID Headquarters and what instructions did you say you give?

Caesar: To put him in custody to take investigation as far as possible.

Commissioner Slowe: You put the man in custody?

Caesar: Orders were he should be placed in custody.

Commissioner Slowe: You told them to set the bail?

Caesar: No.

Commissioner Slowe: You were told by the Chief that he could go on bail?

Caesar: Yes.

Commissioner Slowe: Obviously you assume the Chief would have been Mr.

Blanhum.

Caesar: Yes

Commissioner Slowe: Then it was clarified it wasn't Mr. Blanhum it was Mr. Seelall

Persaud?

Caesar: Yes.

Commissioner Slowe: Did you find it strange?

Caesar: No sir he is the Commissioner of Police.

Commissioner Slowe: Not withstanding the fact you didn't find it strange, would you have put him on bail had you not been instructed to?

Caesar: No sir.

Commissioner Slowe: Well then you must have found it strange, you would not have put him on bail right because I suspect the seriousness of the offense?

Caesar: Yes.

Commissioner Slowe: So you would not have put them on bail but because you were instructed by the Commissioner to send him on bail.

Caesar: The issue did not dawn on my mind at the time.

Commissioner Slowe: It didn't dawn well fair enough fair enough but did you during that time you communicate with your superior Mr. Blanhum the fact that this man is here and that the Commissioner said to put him on bail?

Caesar: I attempt to when I thought it was Mr. Blanhum.

Commissioner Slowe: You tried to get Mr. Blanhum?

Caesar: Yes to tell him.

Commissioner Slowe: That's when you thought it was him but when u realised it was the Commissioner did you decided to tell him that before you lose the man?

Caesar: No Sir.

Commissioner Slowe: You didn't, so why at that time you didn't tell Mr. Blanhum?

Caesar: Sir he is the Commissioner of Police

Commissioner Slowe: No man, that's your line boss your line boss is Mr. Blanhum and according to you have sent this man on bail at the fact the Commissioner Mr. Seelall Persuad intervene and did not see it fit to tell your boss this man was put on bail because the Commissioner told you?

Caesar: Sir I didn't see that would've been fit to tell Crime Chief that Commissioner...

Commissioner Slowe: But why is normal police thing man especially since you would not have sent him on bail you would not have sent it on bail because you are already said so this morning so why wouldn't you have said Mr. Blanhum well the Commissioner sent this guy on bail?

Caesar: Chief I agree with you on almost everything but that is not my style I would not go and report.

Commissioner Slowe: It's not to go and report it's to inform it's not talking name or so it's a cover yourself it's telling my boss well Chief this man here and the Commissioner call to put him on bail, therefore, I will put them on bail

Caesar: From my understanding one of the things also I assumed that the Chief would've already found out.

Commissioner Slowe: The Chief is who? Mr. Blanhum?

Caesar: Yes.

Commissioner Slowe: So you felt that at the time he already knew that the man was going on bail?

Caesar: Yes.

Commissioner Slowe: How you know that? You didn't confirm with him?

Caesar: Think he was in contact with the ranks on the ground also.

Commissioner Slowe: Who Pitama?

Caesar: No no I think Narine based on what I learned when the Narine spoke to me I drew it based on his conversation he was in contact with Mr. Blanhum.

Commissioner Slowe: Who he?

Caesar: Narine was in contact with Mr. Blanhum.

Commissioner Slowe: With Mr. Blanhum?

Caesar: That was my perception.

Commissioner Slowe: Did they inform you of an incident involving the brother of

Nizaam Khan that night?

Caesar: Yes sir.

Commissioner Slowe: What they told you transpired?

Caesar: I was informed that Imran Khan wanted to make a report because he was alleging that Gillard would have threatened him at the station after they would've indicated to him that they don't have an accuse book at CID Headquarters and a message would be sent to Brickdam with the recording he started behaving disorderly.

Commissioner Slowe: You have to report to you?

Caesar: Yes.

July 24th, 201

Commissioner Slowe: And what action did you take?

Caesar: I spoke to Corporal Benjamin that night who I would have instructed to arrest him and they indicated he has a firearm on him I instructed to take the firearm

Commissioner Slowe: And to the best knowledge that was done?

Caesar: Yes, next morning when I came they reported that he was still in custody.

Commissioner Slowe: And what next?

Caesar: He was sent away sir.

Commissioner Slowe: And what happened to the firearm?

Caesar: Returned.

Commissioner Slowe: The firearm was returned to him did you find that strange?

Caesar: I found that strange for a man behaving that behavior at the station using a lot of derogatory remarks and so on for him to be sent away not even on bail.

Commissioner Slowe: Now tell me something Nizam Khan on the 29th when u went to Mr. Blanhum office and you heard them talking about Nizam you at that time knew who Nizam was?

Caesar: Yes.

Commissioner Slowe: You knew who Nizam was?

Caesar: Yes.

Commissioner Slowe: How well?

Caesar: I know him by the station at Grove I investigated the matter in which I

arrested him.

Commissioner Slowe: So you know him?

Caesar: Yes sir.

Commissioner Slowe: And you also know his brother?

Caesar: I know the brother.

Commissioner Slowe: Do you know of any association from otherwise police officers

and so on?

Caesar: Sir I would see him at functions and police functions.

Commissioner Slowe: What kind of functions are you referring to?

Caesar: Parties and so on.

Commissioner Slowe: These parties are what parties where people pay to come?

Caesar: No sir Police parties.

Commissioner Slowe: So, therefore, you formed the opinion that he is close to

policemen?

Caesar: Well somebody in the audience.

Commissioner Slowe: You talking about all ranks?

Caesar: Yes.

Commissioner Slowe: But you don't know exactly who invited him? Did see him sitting at a table drinking with senior officers or at least sitting at the table with senior officers?

Caesar: No. I would see him frequent among everybody in the party.

Commissioner Slowe: And that's not one party several ones? more than?

Caesar: Three.

Commissioner Slowe: In your opinion, the man is a police friend?

Caesar: Yes.

Commissioner Slowe: Because that's what you just called him a police friend whether it's proper or improper you could draw your own conclusion. But based on what you're saying the man is a police friend because you know not every and everybody does lucky to get an invitation to come to police party has to form a close association with some police to come to the party. Because even me sometimes don't get invited, so the man is a police friend?

Caesar: Yes sir.

Commissioner Slowe: And therefore you see him frequently at parties, police stations what more you know of this man?

Caesar: I was told that he has a spare parts business that's what I learned.

Commissioner Slowe: But you stationed at Grove and know about this business?

July 24th, 201

Caesar: Chief I never went to this business.

Commissioner Slowe: No I never said you went.

Caesar: I was told that he has a spare parts business at Grove.

Commissioner Slowe: And he sells to police and so on, he said the man helps repairs police vehicles.

Caesar: I don't know about that Chief that's above my level.

Commissioner Slowe: The Commander said so that is a very good friend of the police. I am getting that this man was brought in you were instructed you told Mr. Blanhum tell me something about the morning when you came in what you did?

Caesar: The next morning I came in I took possession of the statements I went through records to see what was recorded and I went first reported to crime Chief to tell him I was heading over to PLA. I went over and I spoke with her.

Commissioner Slowe: So you went to her on the second occasion to seek guidance, when we went to her this morning you would have talked to her about one statement, the next day, Gillard statement?

Caesar: Yes and the diary.

Commissioner Slowe: Tell me something about the confrontations that we've been hearing about one with Gillard and Nizam that very night one with Gillard and Basdeo and one with Lloyd and Anthony tell me something.

Caesar: Subsequently I think it was a few days after Baldeo would have come and made a statement.

Commissioner Slowe: How long after? two four days?

Caesar: I'm not sure right now I don't want to mislead the commission but I know it's not that long he has made a statement and looking at the statement I immediately asked that Gillard be confronted with him to firstly told what this man was saying and Gillard would've denied. I didn't ask him to confront him. Gillard denied saying he never asked Baldeo to do anything again I informed the PLA on what happened subsequently Anthony contacted us and I invited him to CID headquarters and he made a statement also in which he would've said he's a friend of Gillard and himself and Gillard had a telephone conversation in which Gillard would have told him that he was lying on Khan and he advised him he shouldn't do that it's going to cause a problem this is after he said he would've seen it on television on Travis Chase newscast and I took the statement I went to PLA to get a recording to work with Anthony to see if a recording could be made of the conversation we tried a few days we didn't get through because Anthony was trying to get Gillard and Gillard wasn't answering then when Gillard finally answered he

just speak a few words and phone cuts off. Back to PLA she advised that we do a confrontation at this stage we tried contacting Gillard, (inaudible) went once, Narine went, I went it was reported by Narine that he would call Gillard and Gillard would say in some way that he didn't have the time. On each occasion, records must be made and the statement must be submitted since we realize that time was the essence and the investigation should be completed as soon as possible.

Commissioner Slowe: This Baldeo statement according to Baldeo, Gillard spoke to him on 26th March, as an experienced man I explained that this morning and still find it strange that Gillard approached Baldeo on 26th March three days before Baldeo made the report to the station. How do you view that? No reports were made to the police as yet and three days before this report was made this man came to him and Baldeo and Gillard is saying to Baldeo I want you to go to the station make a statement to the police to the reflect that you were present when this offer was made 3 days before. How do you explain that?

Caesar: At first I took it not to be truth kind of shady but then a few days ago I was contacted by another person who said Gillard would have contacted her before four or five days before he would have made this report so at first I look at it as in not looking good but later on I realize that it could be.

Commissioner Slowe: I'm still trying to find out the logic in that the person accepts the offer then they decided to go to the police the police would say they ain't know what you talking about no such report that's the strange part if you saying that you did not know of the second one but if you have a situation where these people decided to take the offer of this 50,000 dollar or whatever the offer it was and decided to go to the police what statement are they giving the police don't know about anything.

Caesar: At first I didn't look at it as something being serious but it didn't make sense to me.

Commissioner Slowe: The fact that more than one person's, come forward out of that the based before this report made and the rationale behind it the fact that it was a dozen people come forward it still didn't change the guidelines that these were made before the report was made to the police.

Caesar: At the planning stage while planning to do it with seeking assistance.

Commissioner Slowe: Remember they not saying he said go until the 30th or 31st.

Caesar: The information is not that you would go you you're saying that I'm going to do this that is my understanding.

Commissioner Slowe: That is your understanding but that is not what came out that he's going to do it he was saying go to the station and make this report that you were present when this offer was made.

Caesar: That's not what I understand from the statement, sir.

Commissioner Slowe: That's what I understand from the statement of Baldeo and that's what I understand from the evidence Baldeo gave this morning before testimony and on the 26th given the time and estimation.

Caesar: I know he said it was the 26th but that's not my understanding sir. He was saying go and make the report from my understanding he was seeking support to be a witness that was my understanding.

Commissioner Slowe: And your understanding was based on what?

Caesar: From what I would've read.

Commissioner Slowe: But I read the statement and we had the benefit of hearing the man's testimony this morning. Tell me before Baldeo came forward on the 26th some days after 29th did you know Baldeo?

Caesar: No.

Commissioner Slowe: Did you know Lloyd Anthony?

Caesar: Yes.

Commissioner Slowe: How do you know him?

Caesar: I would have arrested him a few times?

Commissioner Slowe: A few times for what?

Caesar: Different offenses robbery.

Commissioner Slowe: I'm not pursuing that you find that's a criminal man tell the police who arrested him so many times.

Caesar: There would have been incidents where he would have come forward and gave us information not only to the arrest but to the conviction of persons.

Commissioner Slowe: We were trying to locate him or contact him for the longest while can you tell me how we can locate him?

Caesar: He would have contacted me Saturday he mentioned to me he heard something on the radio.

Commissioner Slowe: We want him to come because one of the statements he still not coming because he is afraid if he comes forward he would be in danger. Are you aware of the statement?

Caesar: That was as a result of him coming 3 times but after we would've set a time at 10 Mark comes at 2 set a time 2 Gillard comes at 4 at that stage he probably started getting frustrated.

Commissioner Slowe: When Gillard come he had just left. Now you wrote a statement in relation to all that transpired?

Caesar: No.

Commissioner Slowe: You never wrote a statement?

Caesar: Yes I wrote a statement as to what I did in the in the investigation sir.

Commissioner Slowe: And it contained all that would have happened?

Caesar: No sir.

Commissioner Slowe: Why not?

Caesar: Sir that was not part of the initial investigation.

Commissioner Slowe: Who is sparing this investigation?

Caesar: I did sir.

Commissioner Slowe: And not a part of the investigation?

Caesar: I don't see the need.

Commissioner Slowe: No because you're saying you spearheaded investigation and yet still you did not see a need to write a statement of all that transpired?

Caesar: No.

Commissioner Slowe: So you would have refreshed from what?

Caesar: From my general knowledge of the matter.

Commissioner Slowe: Mr. Chang?

Mr. Chang: from the whole presentation with Gillard did you speak about any (inaudible)

Caesar: I would've told Gillard we were told of this conversation Anthony told us he would have and about Gillard telling Anthony he was only pelting "A lash" at him exact words because of what he would have done and so on. I asked Gillard if he knew Lloyd Adams and he said so at that stage I asked him if he was the holder of a number he said yes one he uses the other was bought by his mother and the other was bought by a guy

that was working in his taxi service at that stage he said he knows the number but he doesn't know the man by the name of Lloyd Adams he knows him as Anthony then I asked about the conversation he couldn't remember having that conversation with Anthony. I indicate to him we were told of confrontation all he answered and said is he doesn't know about that (inaudible)

Mr. Chang: You spoke of the confrontation of Baldeo(inaudible)

Caesar: Even before I remembered him saying he don't mind of what Baldeo said he wasn't going with what Baldeo said he denied. I can't remember.

Mr. Chang: (inaudible) If you can't remember you can't remember I don't expect you to. You said that you are known to Anthony. Anthony is known to you. He volunteers that information to your conversation with Gillard. Now you said that you had another statement with a lady (inaudible)?

Caesar: Yes.

Mr. Chang: Of what?

Caesar: She said that she would have known Gillard for some time. Gillard used to rent a cubicle in her salon somewhere at Grove and they used to live opposite each other in Diamond Housing Scheme before she would have learned about the assassination the plot Gillard would have, told her that he's renting a building somewhere and he wants to know that if she wants to be a partner in the renting she said she told him no. And then from one thing to another, he told her that you ain't gone make this report and she said she immediately (inaudible)

Mr. Ram: Good afternoon Mr. Caesar.in your statement, you said you asked him if he knows Lloyd aka Anthony is that correct sir that is the entire statement?

Caesar: Yes.

Mr. Ram: You also said that Mr. Gillard did call Anthony and said to him he is fearful for his life did you inquire from Mr. Gillard fearful for his life the reason for that?

Commissioner Slowe: Was he referring to Gillard or Anthony?

Mr. Ram: He did call Anthony and said he was fearful for his life so I'm referring to. Who would you say is the person you're referring to here as being fearful for his life?

Commissioner Slowe: From what I've read Anthony is the one who made that statement, not Gillard that's why I made clarity on it.

Caesar: Gillard was saying he's fearful for his life after I showed him the telephone print out and he accepts that was the number and that he knows Anthony I did call him and he said he was fearful for his life.

Commissioner Slowe: No we are talking about two different things Gillard apparently did mention that he was fearful because he was told that people looking for him, my understanding is that Anthony said he not coming for no confrontation because he is an Indian man in Albouystown but Gillard also mention at first stage because people looking for him. I just wanted to clarify that.

Mr. Ram: Mr. Caesar you have guidance for the circumstances for refusing bail to a person is that correct sir?

Caesar: Yes.

Mr. Ram: Wouldnt derogatory remarks falls among the circumstances for which Bail should be refused?

Caesar: No.

Mr. Ram: Mr. Imran Khan was always been available to the police if and when necessary?

Caesar: I would not know that we never had any reason to

Mr. Ram: If you had he has never refused?

Caesar: I never witnessed that.

Mr. Ram: No further questions.

Commissioner Slowe: Yes Mr. Chang?

Mr. Chang: (inaudible)

Commissioner Slowe: Before we end this long session today this long interesting session I look forward to tomorrow Mr. Ram, Mr. Chang the other witnesses or the witness we have scheduled tomorrow don't invite them to be too lengthy. I have on the program tomorrow We have two Superintendent detectives Corporal Sewsankar detective, Consultant Pickering was also present at CID Headquarters and in the afternoon Detective Singh and Colonel Benjamin so those are the witnesses we have scheduled for tomorrow.
